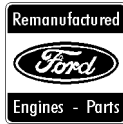

# Dealer Limited (24-Month/Unlimited Mile) Warranty to Customers Purchasing Parts and Accessories from Ford Dealerships

## Coverage Provided

"The Dealer warrants to the original retail Purchaser and to Purchasers at wholesale for subsequent reselling that it will repair or replace without charge, including related labor, any part of any new Ford part or accessory that is sold by the Dealer to the Purchaser that is found to be defective in material or workmanship within a period of 24 months from the date of installation. LABOR FOR REMOVAL AND REINSTALLATION OF PART OR ACCESSORY SOLD OVER THE COUNTER IS NOT COVERED BY THIS WARRANTY.

The only requirement of the Purchaser is that the defective parts or accessories must be returned to the Dealer's place of business during regular business hours for warranty repair or replacement. The Dealer must be furnished with the Purchaser's copy of the original sales slip on counter sales, or Purchaser's copy of the repair order on dealer installations, to validate the date of purchase and vehicle mileage as applicable.

If the Purchaser is travelling or has moved to a different locality any authorized dealer of Ford will fulfill this warranty.

THIS WARRANTY DOES NOT COVER PARTS OR ACCESSORIES THAT FAIL DUE TO ABUSE, MISUSE, NEGLIGENCE, ALTERATION OR ACCIDENT OR WHICH HAVE BEEN IMPROPERLY LUBRICATED OR REPAIRED, OR USED IN APPLICATIONS FOR WHICH THEY WERE EITHER NOT DESIGNED OR NOT APPROVED BY THE COMPANY, OR ARE CLEANED, ADJUSTED OR REPLACED AS A PART OF NORMAL MAINTENANCE, OR SPARK PLUGS THAT ARE OIL FOULED, LEAD FOULED, OR WHICH FAIL DUE TO THE USE OF LOW-GRADE FUEL, IMPROPER SELECTION OF HEAT RANGE OR MISAPPLICATION, OR FAILURES CAUSED BY NON-FORD PARTS.

TO THE EXTENT ALLOWED BY LAW, LOSS OF TIME, INCONVENIENCE, LOSS OF USE OF THE VEHICLE, COMMERCIAL LOSS, OR CONSEQUENTIAL DAMAGES ARE NOT COVERED.

THERE IS NO OTHER EXPRESS WARRANTY ON FORD MOTOR COMPANY SUPPLIED REPLACEMENT PARTS AND ACCESSORIES.

ANY IMPLIED WARRANTY OF MERCHANTABILITY OR FITNESS IS LIMITED TO THE 12 Month/12,000 MILE DURATION OF THIS WRITTEN WARRANTY.

SOME STATES DO NOT ALLOW THE EXCLUSION OR LIMITATION OF CONSEQUENTIAL OR INCIDENTAL DAMAGES OR LIMITATIONS ON HOW LONG AN IMPLIED WARRANTY LASTS, SO THE ABOVE LIMITATIONS AND EXCLUSIONS MAY NOT APPLY TO YOU.

THIS WARRANTY GIVES YOU SPECIFIC LEGAL RIGHTS, AND YOU MAY HAVE OTHER RIGHTS WHICH VARY FROM STATE TO STATE."

(1) With the following exceptions:

- Ford Air Conditioners Kit Assembly (Includes Thermostatic Fan) - 12 months unlimited mileage.
- Motorcraft Shock Absorbers-  
AA, AB, AW, AX Series - Lifetime of original purchaser's ownership of private passenger car or truck. If used in other than private passenger car or light trucks, the warranty period is 24 months or 24,000 miles, whichever occurs first. AJ Series - 12 months/12,000 miles. AM (Cartridges and assemblies), AY Series - 24 months/30,000 miles. AN Series - 24 months/24,000 miles. Labor cost of removal and installation of shock absorbers beyond the standard 12 Month/12,000 mile period is not included.
- Batteries: BXT Tested Tough MAX batteries: 36 months/unlimited mileage; BXL Tested Tough PLUS batteries: 18 months/unlimited mileage. Other battery warranties vary by series. Effective 3-1-21 Forward BXT Tested Tough Max batteries 36 months 100% coverage, BXL Tested Tough Plus batteries 18 months 100% coverage. No Other battery warranties expressed or implied after months have expired. Motorcraft will stand behind the batteries sold with a pro-rata warranty in the past and batteries sold through February 28, 2021. Effective March 1, 2021 Motorcraft will no longer honor pro-rata warranties for batteries sold March 1, 2021 or after.
- Diesel Short Blocks (6009)/stripped long blocks (6012) - 12 months unlimited miles.

**IMPORTANT:** Motorcraft red shock absorbers and batteries with the late style warranty are warranted by Ford Motor Company to the original retail purchaser.
